NOTICE OF CREDENTIAL USE CONDITIONS

Bearer and his or her employer or assigning news organization: (i) assume all risk incident to the performance of services by Bearer and assume all risk incident to Bearer's attendance at the Event, in each case, howsoever caused, whether by negligence or otherwise; (ii) agree to indemnify and hold harmless USAB and its respective affiliates, agents and employees from and against all liability, loss, damage or expense resulting from or arising out of (x) Bearer's presence at the Event, (y) Bearer's acts or omissions and (z) the presence at the venue of any cameras, wires, cabling or other equipment brought on the premises or used by Bearer; and (iii) grant permission to USAB, its affiliates and their respective designees to utilize without compensation Bearer's image, likeness and/or voice in any photograph or live or recorded video or audio display or other transmission or reproduction of the Event or in any excerpt thereof.
